RESULTS OF REMOTE E-VOTING / BALLOT PAPER PROCESS CONDUCTED IN CONNECTION WITH THE 42ND, ANNUAL GENERAL MEETING HELD ON 28TH SEPTEMBER 2016.

Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, entered into with the Stock Exchange, the Company has arranged for Remote E-voting through National Securities Depository Limited. To enable those shareholders who have not availed Remote E-voting facility and who were present at the Annual General Meeting, to participate in the voting process, the Company has arranged for voting through Ballot Paper at the Annual General Meeting.

Remote e-voting was made available to members for 3 days from 9.00 A.M on 25.09.2016 to 5.00 P.M on 27.09.2016.

The Board of Directors of the Company had appointed Sri B.Krishnamoorthi, Chartered Accountant, (Membership No.20439) as the Scrutinizer to oversee the Remote E-voting and Ballot Paper process. The Scrutinizer had scrutinised the votes cast through Remote E-voting and votes cast by Ballot Paper at the Annual General Meeting, combined the votes and submitted his Report to the Chairman of the Company. I, B. Krishnamoorthi, BSc, FCA Practicing Chartered Accountant, Coimbatore was appointed as Scrutinizer for the 42nd (Forty Second) Annual General Meeting of the Shareholders of "**Lakshmi Automatic Loom Works Limited**" held on 28th September 2016 at 3.30 pm at the registered office of the Company at : 686, Avanashi Road, Pappanaickenpalyam, Coimbatore – 641037 for the purpose of scrutinizing the E-Voting process and Physical Ballot voting at the venue in a fair and transparent manner and ascertaining the requisite majority on E-Voting and Physical Ballot voting at venue carried out as per section 108 of the Companies Act, 2013 and rule 20(4) (xii) of the Companies (Management and Administration) Amendment Rules, 2015 on the resolutions referred to in this report.

I submit my report as under:

1. The Notice was sent to all the Members, whose names appeared in the Register of Members as on 26th August, 2016 to vote on the proposed 4 (Four) Resolutions as mentioned in the Notice of the Annual General Meeting of "Lakshmi Automatic Loom Works Limited" (Item No.1 (One) to 4 (Four) of the Notice of Annual General Meeting of Lakshmi Automatic Loom Works Limited. Only the Members holding shares as on the cut-off date i.e. 21st September, 2016 were considered for e-voting and for voting at the meeting venue.
2. The E-Voting period remained open from 09.00 AM on Sunday 25th September, 2016 up to 05.00 PM on Tuesday 27th September, 2016.
3. The Chairman, at the Annual General Meeting, at the end of discussions on the Resolutions contained in the Notice, allowed voting at the venue of the Annual General Meeting on the Ballot Forms provided at the Meeting venue to all those members who were present at the Meeting but have not cast their votes by availing the remote e-voting.

4. After the conclusion of the Meeting, the Ballot Boxes were opened in my presence and the physical ballot forms were diligently scrutinized and reconciled with the records maintained by the Registrar and Transfer Agents of the Company. I thereafter first counted the votes cast at the Meeting through these Ballot Forms.
5. The Votes cast through E-Voting were unblocked on 28th September, 2016 around 4.12 PM in the presence of two witnesses, namely Mr.K.Marimuthu and Mr.R.Sasidharan, who are not in employment of the Company.
6. In tune with the Instructions contained in the instructions given for e-voting sent along with the Notice dated 12th August, 2016, in respect of members who have voted in both modes (i.e. E-Voting and Physical Ballot form voted at the venue), I have considered only E-Voting by not reckoning the voting done through Ballot Form.
7. 1 Ballot Form involving 150 shares which was incomplete and / or otherwise defective was treated as invalid.
8. Two shareholders holding 8,50,000 Preference shares of Rs.100/- each have voted for all the resolutions. Since the dividend for last two years has not been paid on the Preference shares, the Preference shareholders get the right to vote on all the resolutions to be passed at this Annual General meeting. Since the paid up amount per Preference share is Rs.100/- as against Rs.10/- paid up on Equity share, the voting rights for each Preference share will be 10 (Ten) votes and voting rights for each Equity share will be 1 (one) vote.
9. I have collated the votes received through E-Voting process, Ballot forms received by post and Physical Ballot forms voted at venue and the same have been furnished hereunder.



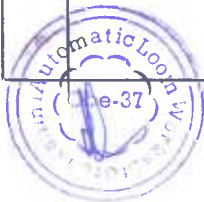
